STATE UPDATES



KANSAS - "The top 2020 priority for KARA will be working on legislation to create a state pesticide waste disposal fund and program," reports Randy Stookey, JD, Sr. VP, General Counsel, Kansas Agribusiness Retailers Association (KARA). We will also be working on legislation on the following

issues: adoption of reportable quantities of hazardous chemical spills; opposing additional requirements or limitations on herbicide products or applications; supporting passage of the next 10-year transportation plan; creating a statutory cap on non-economic damages (pain and suffering) in personal injury cases; opposing the imposition of a sales tax on agricultural services; and, extending the life of the state's underground petroleum storage tank fund and program.


While the AgriBusiness Expo was held in November there was a great turnout for two of our speakers this year: (1) KS Highway patrol discussed weight limits and other relevant regulations, and (2) a presentation on workforce development by a person from the Kansas Dept. of Agriculture.



MINNESOTA - "The number one legislative issue the Minnesota Crop Production Retailers (MCPR) will be working on in 2020 is keeping large cities in MN from regulating pesticides within their boundaries and keeping MN Ag Superfund Account paid by ag industry fees to fund only ag industry cleanup rather than adding in all private and public wells," stated Bill Bond, MCPR, Executive Director.

The MCPR annual trade show was held December 10-12, 2019 with the two hot topics being the ag economy and sustainability -

use of cover crops.



SOUTH DAKOTA - "The South Dakota Department of Agriculture (SDDA) is looking to increase funding for its regulatory and recycling programs with across the board increases in fees including pesticide registration fees, pesticide dealer licenses and private applicator license," reports **Kathy Zander**, **Executive Director**, **South Dakota Agri-Business (SDABA)**

Association. SDABA is working close with SDDA to ensure fees are needed and shared by all those that benefit from these programs. It will get interesting since farm groups don't want any increases and Governor Noem doesn't want any "tax" increases and is looking for state agencies to cut 10% from their budgets.

Hot topics for the SDABA annual conference will focus on "Bridging the Gap between Farmers and Consumers", "Weathering the Storm in Agriculture" and "It Starts with Attitude."

WISCONSIN - "The top legislative issue for the Wisconsin Agri-Business association is working with the Speaker's Task Force on Water Quality, making sure the legislature is educated on the good management practices already employed by the retail agronomy and plant protection industry," says Tom Bressner, Executive Director, Wisconsin Agri-Business Association.

This year's conference scheduled for later this month has 57 educational breakout session topics being presented. The top two in my mind are "Industrial Hemp Research (Grain, Fiber and CBD) in Wisconsin - Lessons from Year 1" and "Operating Your Business during Economically Challenging Times".
