STATE UPDATES



IOWA - "After suspending the session on March 16, the Iowa legislature is planning to resume on June 3," says Tyler Teske, Marketing Director, Agribusiness Association of Iowa (AAI). It is expected to be short with an emphasis on high priority items previously identified by legislative leaders and an amended State of Iowa budget based on the

impacts of the Pandemic. Introduction of additional legislation outside of Pandemic response is highly unlikely.

The state's COVID-19 response has moved from tight restrictions on non-essential businesses to a wider allowance for businesses to operate under certain guidelines. The governor identified the ag sector early on as essential and many regulations were eased including renewal requirements for commercial pesticide applicator certification, CDL renewals, and truck weights on state roads.

The pandemic threw a wrench into testing for new commercial pesticide applicators closing down testing sites. The lowa Department of Agriculture and Land Stewardship (IDALS) has implemented a solution utilizing in-car testing in parking garages at various locations around the state to maintain social distancing and protect both proctors and participants. The drive-up testing is a welcome help as the growing season is already in full swing with planting largely completed well ahead of recent years.

That early planting of increased corn acres into ideal conditions is already causing concern for ag retailers as they anticipate storage capacity issues. With ethanol production all but halted earlier this year due to unfavorable market conditions, and disruptions in feed use due to packing plant closures and slower processing, corn movement has been significantly slowed.

Agricultural retailers continue to limit customer interactions to keep staff healthy and avoid extended shutdowns. The AAI staff has been working remotely since March 16 with all committee and board meetings being conducted via teleconference. Many member businesses are not allowing travel or gatherings and there currently are no near-term plans to resume in-person meetings for association business.



KANSAS - "On Thursday, May 21st, the Kansas legislature returned for one final day of business, working overnight through 24 straight hours of debate and deliberation before adjourning for the year," reports Randy Stookey, JD, Sr. VP, General Counsel, Kansas Agribusiness Retailers Association (KARA).

KARA had anticipated a final vote in the Senate on House Bill 2432, a bill which would have established a pesticide waste disposal program with funding from the Kansas Agricultural Chemical Remediation Reimbursement Fund. This was to be a limited scope, good stewardship program for our industry to be run by the Kansas Dept. of Agriculture. Unfortunately, the COVID-19 pandemic created a truncated timeframe for the legislature which limited its action to only those bills that were arguably related to the pandemic.

As for COVID-19, KARA worked with our Governor early on to secure a truck weight waiver for agricultural inputs and receive special CDL licensing renewals for seasonal drivers. Legislative action last week, however, will bring about the expiration of our state of disaster emergency no later than May 31st. At that point, Kansas law allows each county commission to consider issuing its own county-wide health order.

Kansas has been wet and mostly cool this spring, but hopefully the sun will begin to shine in the final week of May and first weeks of June in order to dry out a bit for winter wheat harvest and double-crop plantings.



MINNESOTA - "The MN Legislative Session fizzled at the end and a Special Session has been scheduled for June," says Bill Bond, Executive Director, Minnesota Crop Production Retailers (MCPR). Part of the problem is MN after the COVID-19 shutdown faces a \$2.43 billion deficit, a nearly \$4 billion dive from the \$1.5 billion surplus projected just months ago which makes the "tax expenditures" to solve the MCPR priority IRS Section 179 expensing tax issue all the more difficult to secure. Two pieces of legislation that did not pass in this session were the Capital Investment Bonding bill and the Omnibus Tax

bill which were linked but fated for failure due to no agreement between the DFL House and GOP Senate Related to ag interests, the Omnibus Agriculture Policy bill became law which includes initiatives requested by the Minnesota Department of Agriculture, along with provisions from a host of other bills heard by the respective Senate and House Agriculture Committees this session with modifications to state seed and noxious weed laws, laws governing perishable farm product buyers, state loan programs, eggs, meat and poultry inspections, farm safety, grain buyers, emerging farmers, industrial hemp, agricultural education, pet food and several technical changes to the composition of Minnesota Agricultural Education Leadership Council. WISCONSIN - "The Wisconsin Legislature has finished its session for the year," reports Tom Bressner, Executive Director, Wisconsin Agri-Business Association (WABA). If they do come back for a special session, it will be only for COVID-19 related actions. It is of note that June 1 is the official beginning of the campaign season. Despite moving to a zoom meeting format, candidate meet and greets and fundraisers are alive and well.

As for COVID-19, the five person staff of WABA is doing well. While it is definitely not business as usual, weekly staff conference call meetings

and lots of phone calls and emails has kept us moving in the same direction. If Wisconsin numbers (new cases, deaths, negative test results, etc.) continue to improve, we hope to be back in the office on June 9th utilizing special sanitation procedures.

For the most part, crops are planted in Wisconsin. However seed beds and growing conditions have been far from ideal. Warm weather and a little dry spell would be a very welcome sight.
