### STATE UPDATES



KANSAS - "Kansas' House of Representatives recently passed House Bill 2432 favorably on a vote of 122-0," reports Randy Stookey, JD, Sr. VP, General Counsel, Kansas Agribusiness Retailers Association (KARA). This bill would establish the Kansas Pesticide Waste Disposal Program and Fund within the

Kansas Dept. of Agriculture. The program would provide for the safe collection and disposal of pesticide waste materials from agricultural producers and retailers. The program would be funded by an annual transfer of up to \$50,000 from the existing Kansas Agricultural Remediation Fund. KARA sought introduction of this bill as sound public policy and industry stewardship. The bill now moves to the Senate for consideration.

While not a regulation, KARA is working with the Kansas Dept. of Agriculture on guidance documents for "use" (including storage, handling, loading, mixing, and application) of Paraquat and Dicamba products under EPA's most recent label directions in order to ensure that our retailer-members receive clear guidance on the agency's interpretation of the label.



ILLINOIS - "It's been very busy at the Illinois General Assembly and much of the legislation is dealing the crop protection products," reports Kevin "KJ" Johnson, Director of Government & Industry Relations, Illinois Fertilizer & Chemical Association (IFCA). This is a list of bills that IFCA is working in Springfield regarding crop protection products:

- Pesticide Penalties Bill --- SB2507 and HB4971
- Applicator to Notify Beekeeper of Pesticide Application ---SB2943
- Chlorpyrifos Ban --- HB5608
- Banning Neonicotinoid Pesticide on State of Illinois Lands --- HB4381
- Environmental Justice --- HB4606

IFCA will keep MACA in the loop if any of these bills start moving forward. There are no new regulations right now in the state of Illinois on crop protection products. We're taking many calls and emails from applicators that are getting warning letters/monetary penalties from the Illinois Department of AG on dicamba application. The Department of AG has let us know that they're only halfway through the 2019 season on pesticide drift complaints.



WISCONSIN - "Numerous bills were introduced and passed in the State Assembly in February, focusing on helping farmers during a challenging agricultural economy, and bills focusing on water quality issues across the state," reports Tom Bressner, executive director, Wisconsin Agri-Business
Association. "Even though these bills all passed the Assembly, they will come under much more scrutiny in the Senate. The state Senate will take up these bills in March. I believe some will pass the Senate, but many will not."

During the last week of February, we held our first meeting (of many) at the Department of Natural Resources. The group is called the Statute NR 151 - Nitrate Targeted Performance Standards Technical Advisory Council. The council is made up of various interests from conventional and organic farmers, environmentalists, water quality specialists, scientists, agronomists, nutrient management plan writers,

etc..., to try to come up with a workable plan to reduce water nitrate issues going forward.
